How to become ITAD Certified?

I. ASCDI Membership

Must be an ASCDI Member in good standing in the ASCDI ethics program.

II. Certification in at least one of the following:

A. Electronics Reuse/Recycling Certification

R2:2013 R2v3 with Appendices A (downstream) & C (testing) e-Stewards v4.0

B. Data Security Certification

R2v3 with Appendix B (data)

NAID AAA for hard drive erasure or destruction

ADISA

III. ITAD Services - demonstrates the capability to perform the following services:

A. Reverse Logistics - managed by the ITAD company. Packing and freight may be subcontracted. Must have the ability to track shipments.

B. Data Sanitization - at the client site or in-house (not subcontracted).

- C. Testing and Resale in-house
- D. Audit Reporting in-house
